#### SETTLEMENT AGREEMENT

THIS SETTLEMENT AGREEMENT (this "Agreement") is made and entered into effective as of the \_\_\_\_ day of August, 2018 (the "Effective Date"), by and between CARDINAL SERVICING COMPANY, LLC ("Cardinal"), a Delaware limited liability company, INDIGO COMMUNITY DEVELOPMENT DISTRICT, a local unit of special purpose government (the "District") duly organized and existing under the provisions of the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, as amended (the "Act") and U.S. BANK NATIONAL ASSOCIATION, a national banking association, as Trustee (the "Trustee"). In this Agreement, Cardinal, District and Trustee are hereinafter sometimes referred to separately as "Party" and collectively as "Parties".

#### **RECITALS**

- A. The District is a local unit of special purpose government duly organized and existing under the provisions of the Act, by rule of the Florida Land and Water Adjudicatory Commission effective January 3, 1995 and is validly existing under the Constitution and laws of the State of Florida.
- B. Pursuant to the authority of the Act, the District issued its Capital Improvement Revenue Bonds, Series 1999C (the "1999C Bonds") and its Capital Improvement Revenue Bonds, Series 2005 (the "2005 Bonds" and together with the 1999C Bonds the "District Bonds") for purposes of financing various infrastructure improvements within the District which provides benefits to the lands within the District.
- C. The Series 1999C Bonds were issued pursuant to the Act and the Master Trust Indenture, dated as of July 1, 1999 (the "Master Indenture"), by and between the District and the Trustee as supplemented by that certain First Supplemental Trust Indenture, dated as of July 1, 1999.
- D. The Series 2005 Bonds were issued pursuant to the Act and the Master Indenture, as supplemented by that certain Fourth Supplemental Trust Indenture, dated as of February 1, 2005.
- E. Pursuant to the Act and Chapter 170, Florida Statutes, as amended, the District levied non-ad valorem special assessments (the "Debt Assessments") securing the District Bonds on those developable portions of the benefitted lands within the District.
- F. Pursuant to the Act and Chapter 170, Florida Statutes, as amended, the District also levied non-ad valorem special assessments (the "O&M Assessments") to pay the operating and maintenance expenses of the District.

- G. Cardinal recently acquired the eleven parcels described on Exhibit A-I(the "Delinquent Parcels") and is in the process of acquiring two additional parcels (the "Additional Parcels") within the District also described on Exhibit A-II.
- H. There exists certain delinquencies in Debt Assessments and O&M Assessments against the Delinquent Parcels and the Additional Parcels.
- I. Cardinal desires to enter into this Agreement pay the amounts described herein to cure the delinquencies against the Delinquent Parcels and outline terms for the payment of delinquencies against the Additional Parcels at such time as Cardinal obtains the fee interest title to the Additional Parcels.
- J. The District, through the Trustee, has received direction from not-less-than one hundred percent (100%) of the holders of the District Bonds to enter into this Agreement on their behalf.

**NOW**, **THEREFORE**, based upon good and valuable consideration and the mutual covenants of the parties, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. INCORPORATION OF RECITALS. The recitals stated above are true and correct and are incorporated by reference herein as a material part of this Agreement.
- **2. CARDINAL OBLIGATIONS.** In order to induce the District and Trustee to execute, deliver and perform under this Agreement, Cardinal covenants and agrees to pay the following amounts with respect to the Delinquent Parcels within ten (10) business days of the Effective Date:
  - (A) to pay the delinquent principal amortization installments due with respect to the 1999C Bonds in an amount equal to \$171,411.19 and its 2005 Bonds in an amount equal to \$527,973.68 and begin to pay the balance of the principal and interest assessments as such amounts would come due after the Debt Assessments are decelerated and the original amortization schedule is reinstituted;
  - (B) to pay 50% of the past due accrued and unpaid interest due with respect to the 1999C Bonds in an amount equal to \$196,735.58 and with respect to the 2005 Bonds in an amount equal to \$741,014.08; and
  - (C) to pay the O&M Assessments currently outstanding and levied against the Delinquent Parcels in an amount equal to \$259,520.24;

Cardinal covenants and agrees to pay the following amounts with respect to the Additional Parcels within sixty (60) days following the Effective Date:

- (A) to pay the delinquent principal amortization installments due with respect to the 1999C Bonds in an amount equal to \$ 451,843.35 and begin to pay the balance of the principal and interest assessments as such amounts would come due after the Debt Assessments are decelerated and the original amortization schedule is reinstituted;
- (B) to pay past due accrued and unpaid interest due with respect to the 1999C Bonds in an amount equal to \$740,972.48; and
- (C) to pay the O&M Assessments currently outstanding and levied against the Delinquent Parcels in an amount equal to \$152,254.80.

Upon payment of the above described amounts the District and Trustee warrant and represent Cardinal will be current in all amounts owed to the District with respect to the Delinquent Parcels with only future balances coming due on or after November 1, 2018.

- **3.** In order to induce Cardinal and Trustee to execute, deliver and perform under this Agreement, the District covenants and agrees that upon receipt of the payments for the Debt Assessments and the O&M Assessments related to the Delinquent Parcels, as described herein, the District shall:
  - (A) waive all penalties imposed on the past due O&M Assessments;
  - (B) waive all penalties imposed on the past due Debt Assessments;
  - (C) waive the remaining past due accrued and unpaid interest on the past due Debt Assessments;
  - (D) execute and record a satisfaction of lien for all unpaid assessments due in connection with the Delinquent Parcels, including those liens listed on Exhibit B; and
  - (E) release, or cause the Trustee to release all mortgage interest in the Delinquent Parcels.
- 4. In order to induce Cardinal and Trustee to execute, deliver and perform under this Agreement, the District covenants and agrees that upon receipt of the payments for the Debt Assessments and the O&M Assessments related to the Additional Parcels, as described herein, the District shall:
  - (A) waive all penalties imposed on the past due O&M Assessments;
  - (B) waive all penalties imposed on the past due Debt Assessments;
  - (C) waive the remaining past due accrued and unpaid interest on the past due Debt Assessments;

- (D) execute and record a satisfaction of lien for all unpaid assessments due in connection with the Delinquent Parcels, including those liens listed on Exhibit B; and
- (E) release, or cause the Trustee to release all mortgage interest in the Delinquent Parcels.

Upon payment of the above described amounts the District and Trustee warrant and represent Cardinal will be current in all amounts owed to the District with respect to the Additional Parcels with only future balances coming due on or after November 1, 2018.

- 5. DEEMED AMENDMENT OF INDENTURE; CONSENT. To the extent that the provisions of this Agreement conflict with any provision of the Master Indenture, the Master Indenture shall be deemed to be amended to conform to the conflicting provision of this Agreement. Consent to such amendment shall be evidenced in the written consent of the Beneficial Owners of one hundred percent (100%) of the outstanding District Bonds to this Agreement, including, but not limited to, the provisions of this Section 8 and direction to the Trustee to execute this Agreement in their stead and on their behalf.
- **6. AGREEMENT**. This instrument shall constitute the final and complete expression of this Agreement among the parties relating to the subject matter of this Agreement.
- 7. AMENDMENTS. Amendments to and waivers of the provisions contained in this Agreement may be made only by an instrument in writing which is executed by all of the parties hereto.
- **8. AUTHORIZATION**. The execution of this Agreement has been duly authorized by the appropriate body or official of all Parties hereto, each Party has complied with all the requirements of law, and each Party has full power and authority to comply with the terms and provisions of this instrument.
- 9. THIRD PARTY BENEFICIARY. The Parties hereto agree and acknowledge that the Trustee is executing this Agreement with the consent of, and at the direction of, the Bondholders of the District Bonds and that the Bondholders of the District Bonds, although not a signatory hereto, are nonetheless third party beneficiaries of this Agreement.
- 10. CONTROLLING LAW AND VENUE. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of Florida. Each Party consents that the venue for any litigation arising out of or related to this Agreement shall be in Volusia County, Florida.
- 11. ENFORCEMENT OF AGREEMENT. In the event that a party is required to enforce this Agreement by court proceedings or otherwise, then the Parties agree that the prevailing party shall be entitled to recover from the defaulting party all fees and costs incurred, including reasonable attorneys' fees and costs for trial, alternative dispute resolution,

or appellate proceedings which amounts may be recovered from the proceeds of the foreclosure of the Forbearance Parcels as provided in Section 7 hereof.

- 12. EFFECTIVE DATE AND TERM. This Agreement shall be effective as of the Effective Date and shall terminate on the Forbearance Termination Date as described in Section 3 herein. At such time all Delinquent Assessments that are due and owing, including, but not limited to Debt Assessments that accrue during the Forbearance Period, shall immediately become due and payable to the District.
- 13. CARDINAL'S REPRESENTATIONS, WARRANTIES AND COVENANTS. Cardinal hereby represents and warrants to the District and the Trustee that:
- (a) Cardinal is a limited liability company, duly organized and validly existing in the State of Delaware;
- (b) Cardinal has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations hereunder;
- (c) The person executing this Agreement on behalf of Cardinal represents that he or she is duly authorized to execute this Agreement and to bind Cardinal;
- (d) Neither the execution and delivery of this Agreement nor the performance hereunder by Cardinal will result in any breach of, or constitute a default under or conflict with, any agreement, covenant or obligation binding upon Cardinal; and
- (e) This Agreement has been duly authorized and executed by Cardinal in accordance with the articles of organization, operating agreement and other applicable organizational documents of Cardinal.
- **14. REPRESENTATIONS AND WARRANTIES OF THE DISTRICT**. The District hereby represents and warrants to Cardinal and the Trustee that:
- (a) The District is a unit of special purpose government duly organized and validly existing in good standing under Chapter 190, Florida Statutes;
- (b) The District has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations under this Agreement;
- (c) This Agreement has been duly authorized and executed by the District in accordance with all applicable law and authority documents applicable to the District;
- (d) The person executing this Agreement on behalf of the District represents that he or she is duly authorized to execute this Agreement and to bind the District; and

- (e) Neither the execution and delivery nor the performance of this Agreement by the District conflicts with, is a breach of, or constitutes a default under, any agreement, covenant or obligation binding upon the District.
- **15. REPRESENTATIONS AND WARRANTIES OF THE TRUSTEE**. The Trustee hereby represents and warrants to Cardinal and the District that:
- (a) The Trustee is a national banking association duly organized and validly existing in good standing under the law of the United States;
- (b) The Trustee has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations under this Agreement;
- (c) This Agreement has been duly authorized, executed and delivered by the Trustee in accordance with all applicable organizational and authority documents of Trustee and any agreements binding upon Trustee;
- (d) The person executing this Agreement on behalf of the Trustee represents that he or she is duly authorized to execute this Agreement and to bind the Trustee; and
- (e) Neither the execution and delivery nor the performance of this Agreement by the Trustee conflicts with, is a breach of, or constitutes a default under, any agreement, covenant or obligation binding upon the Trustee.
- 16. NOTICES. Except as may be expressly stated to the contrary in this Agreement, notices, documents, demands, or certificates given by any Party in connection with this Agreement or the performance by either Party under this Agreement shall be in writing and shall be delivered or sent by one of the following methods: (a) in person (by hand delivery or professional messenger service) to the addressee Party, (b) registered or certified mail, with postage prepaid, return receipt requested, (c) Express Mail of the U.S. Postal Service or Federal Express (a/k/a FedEx) or any other courier service guaranteeing next business day delivery, charges prepaid, or (d) by facsimile transmission (provided a hard copy of such transmission is simultaneously sent or delivered by one of the above prescribed methods). Notices shall be sent or delivered to the following addresses:

Any such notice, document, demand, or certificate sent by registered or certified mail, return receipt requested, shall be deemed to have been duly given and received upon the earlier of actual receipt or seventy-two (72) hours after the same is so addressed and mailed with postage prepaid. Notices delivered by Express Mail of the U.S. Postal Service or Federal Express (a/k/a FedEx) or other courier service guaranteeing next business day delivery shall be deemed to have been given twenty-four (24) hours after delivery of the same to the U.S. Postal Service or private courier, with charges prepaid and instructions for next business day delivery. If any notice is transmitted by facsimile transmission or similar means, the same shall be deemed served or delivered upon electronic confirmation of transmission thereof. Any notice, document, demand, or certificate sent by any other method shall be effective only upon actual receipt thereof or the addressee's refusal to accept delivery, whichever occurs first. Any Party may change its address for purposes of this section by giving notice to the other Party as provided herein.

- 17. TIME OF THE ESSENCE. Time shall be of the essence as to all dates, deadlines and times of performance under this Agreement. Notwithstanding the foregoing, in the event any date or any deadline for the performance of an action or the giving of any notice falls on any day that is not a Business Day, or any period provided for in this Agreement shall expire on any day that is not a Business Day, then the date for the performance of such action or giving of such notice, or the expiration date of such period, as applicable, shall be automatically extended to midnight of the next following Business Day. For the purposes of this Agreement, the term "Business Day" shall mean and refer to any day that is not a Saturday, Sunday, or national holiday.
- **18. GOOD FAITH AND FAIR DEALING**. The Parties agree to exercise good faith and fair dealing in the performance of their respective contractual obligations hereunder.
- 19. PUBLIC RECORDS. The Parties understand and agree that all documents of any kind provided to the District or Cardinal in connection with this Agreement may be public records and treated as such in accordance with Florida law.
- **20. SURVIVAL OF CERTAIN PROVISIONS.** The provisions of Sections 7, 13, 14, 22 and 25 of this Agreement shall survive the expiration or earlier termination of this Agreement.
- 21. SEVERABILITY. The invalidity or unenforceability of any one or more provisions of this Agreement shall not affect the validity or enforceability of the remaining portions of this Agreement, or any part of this Agreement not held to be invalid or unenforceable.
- 22. LIMITATIONS ON GOVERNMENTAL LIABILITY. Nothing in this Agreement shall be deemed as a waiver of immunity or limits of liability of the District beyond any statutory limited waiver of immunity or limits of liability which may have been adopted by the Florida Legislature in Section 768.28, Florida Statutes, or other statute, and nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law. In addition, any provision of this Agreement to the contrary notwithstanding, the Trustee has executed this Agreement only in its capacity as the trustee under the Master Indenture and only for the purpose of evidencing the consent of the Bondholders of the District Bonds to the transactions contemplated herein, and not individually or for the purpose of being bound in its individual or personal capacity. The Trustee shall not have any individual or personal liability under or related to this Agreement
- 23. **FURTHER ASSURANCES.** The Parties agree to execute, acknowledge, deliver and record such certificates, amendments, instruments, and documents, and to take such other action, as may be reasonably necessary to carry out the intent and purposes of this Agreement.

The Property listed above has been assigned (681) (Single Family Residential) Assessment Units per the District's April 2, 2014 Supplemental Special Assessment Methodology Reports for the Capital Improvement Revenue Bonds, Series 1999C and Series 2005 ("Methodologies").

This Property is subject to (2) Bond Issues, Series 1999C Bond Debt, maturing May 1, 2030 and Series 2005 Bond Debt maturing May 1, 2036 ("Bonds"). Both Bonds are secured by annual Debt Service Assessments equal to the Bonds' annual principal and interest payment ("Debt Service Assessments"). Pursuant to Florida Statute 170.10, upon default in payment of Debt Service Assessments, the whole Assessment, with interest and penalties thereon, shall immediately become due and payable and subject to foreclosure.

The total amount currently due for the Series 1999C Debt is \$660,077.33. This amount is comprised of the current principal balance of the Series 1999C Bonds related to this Property of \$354,511.99, accrued interest at 7% of \$117,901.29, as well as penalties of 1% per month accrued on the past due balances pursuant to Section 170.09, Florida Statutes of \$187,664.06. Interest is through fiscal year 2018 and penalties are through 6/30/18, please note that there are significant amounts of accrued interest and penalties on Bond balances prior to restructure as well as balances post restructure. Past due Series 1999C principal payments through fiscal year 2018 total \$57,990.97. If this Property is made current, the gross Series 1999C Debt Service Assessment will be \$39,715.92.

Please take notice that the District is unable to accept partial late payments without the express consent of the trustee on behalf of bondholders.

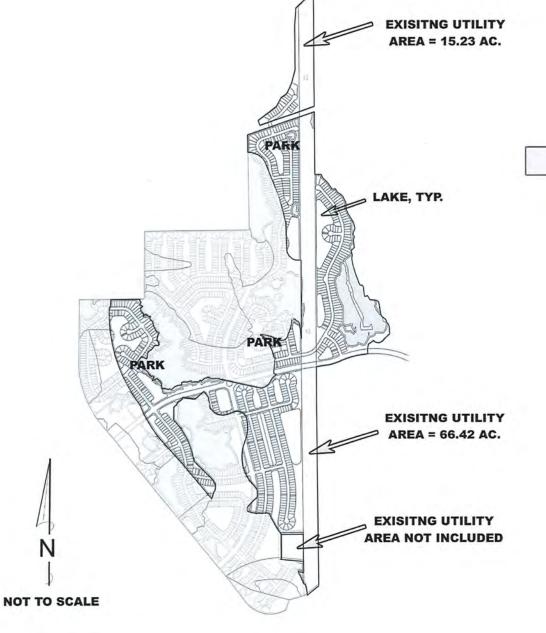

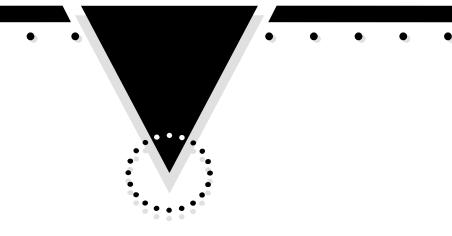

### **RESOLUTION 2018-03**

THE ANNUAL APPROPRIATION RESOLUTION OF THE INDIGO COMMUNITY DEVELOPMENT DISTRICT ("DISTRICT") RELATING TO THE ANNUAL APPROPRIATIONS AND ADOPTING THE BUDGETS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019; AUTHORIZING BUDGET AMENDMENTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the District Manager has, prior to the fifteenth (15<sup>th</sup>) day in June, 2018, submitted to the Board of Supervisors ("**Board**") of the Indigo Community Development District ("**District**") proposed budget ("**Proposed Budget**") for the fiscal year beginning October 1, 2018 and ending September 30, 2019 ("**Fiscal Year 2017-2018**") along with an explanatory and complete financial plan for each fund of the District, pursuant to the provisions of Section 190.008(2)(a), *Florida Statutes*; and

WHEREAS, at least sixty (60) days prior to the adoption of the Proposed Budget, the District filed a copy of the Proposed Budget with the local governing authorities having jurisdiction over the area included in the District pursuant to the provisions of Section 190.008(2)(b), *Florida Statutes*; and

**WHEREAS**, the Board set August 22, 2018, as the date for a public hearing thereon and caused notice of such public hearing to be given by publication pursuant to Section 190.008(2)(a), *Florida Statutes*; and

**WHEREAS**, the District Manager posted the Proposed Budget on the District's website at least two days before the public hearing; and

**WHEREAS,** Section 190.008(2)(a), *Florida Statutes*, requires that, prior to October 1<sup>st</sup> of each year, the District Board, by passage of the Annual Appropriation Resolution, shall adopt a budget for the ensuing fiscal year and appropriate such sums of money as the Board deems necessary to defray all expenditures of the District during the ensuing fiscal year; and

WHEREAS, the District Manager has prepared a Proposed Budget, whereby the budget shall project the cash receipts and disbursements anticipated during a given time period, including reserves for contingencies for emergency or other unanticipated expenditures during the fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE INDIGO COMMUNITY DEVELOPMENT DISTRICT:

SECTION 1. BUDGET

- a. The Board of Supervisors has reviewed the Proposed Budget, a copy of which is on file with the office of the District Manager and at the District's Records Office, and hereby approves certain amendments thereto, as shown in Section 2 below.
- b. The Proposed Budget, attached hereto as **Exhibit "A,"** as amended by the Board, is hereby adopted in accordance with the provisions of Section 190.008(2)(a), *Florida Statutes* ("**Adopted Budget"**), and incorporated herein by reference; provided, however, that the comparative figures contained in the Adopted Budget may be subsequently revised as deemed necessary by the District Manager to reflect actual revenues and expenditures.
- c. The Adopted Budget, as amended, shall be maintained in the office of the District Manager and at the District's Records Office and identified as "The Budget for the Indigo Community Development District for the Fiscal Year Ending September 30, 2019."
- d. The final adopted budget shall be posted by the District Manager on the District's official website within thirty (30) days after adoption, and shall remain on the website for at least 2 years.

### **SECTION 2. APPROPRIATIONS**

There is hereby appropriated out of the revenues of the Indigo Community Development District, for the fiscal year beginning October 1, 2018, and ending September 30, 2019, the sum of \$\_\_\_\_\_\_ to be raised by the levy of assessments and otherwise, which sum is deemed by the Board of Supervisors to be necessary to defray all expenditures of the District during said budget year, to be divided and appropriated in the following fashion:

### **SECTION 3. BUDGET AMENDMENTS**

Pursuant to Section 189.016, *Florida Statutes*, the District at any time within the fiscal year or within 60 days following the end of the fiscal year may amend its budgets for that fiscal year as follows:

- a. The Board may authorize an increase or decrease in line item appropriations within a fund by motion recorded in the minutes if the total appropriations of the fund do not increase
- b. The District Manager or Treasurer may authorize an increase or decrease in line item appropriations within a fund if the total appropriations of the fund do not increase and if the aggregate change in the original appropriation item does not exceed \$10,000 or 10% of the original appropriation.
- c. By resolution, the Board may increase any appropriation item and/or fund to reflect receipt of any additional unbudgeted monies and make the corresponding change to appropriations or the unappropriated balance.
- d. Any other budget amendments shall be adopted by resolution and consistent with Florida law

The District Manager or Treasurer must establish administrative procedures to ensure that any budget amendments are in compliance with this Section 3 and Section 189.016 of the *Florida Statutes*, among other applicable laws. Among other procedures, the District Manager or Treasurer must ensure that any amendments to budgets under subparagraphs c. and d. above are posted on the District's website within 5 days after adoption.

**SECTION 4. EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption.

### RESOLUTION 2018-04

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE INDIGO COMMUNITY DEVELOPMENT DISTRICT IMPOSING SPECIAL ASSESSMENTS AND CERTIFYING AN ASSESSMENT ROLL; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the Indigo Community Development District ("District") is a local unit of special-purpose government established pursuant to Chapter 190, Florida Statutes for the purpose of providing, operating and maintaining infrastructure improvements, facilities and services to the lands within the District; and

WHEREAS, the District is located in Volusia County, Florida ("County"); and

**WHEREAS**, the District has constructed or acquired various infrastructure improvements and provides certain services in accordance with the District's adopted Improvement Plan and Chapter 190, Florida Statutes; and

WHEREAS, the Board of Supervisors ("Board") of the District hereby determines to undertake various operations and maintenance activities described in the District's budget for Fiscal Year 2018-2019 ("Operations and Maintenance Budget"), attached hereto as Exhibit A and incorporated by reference herein; and

WHEREAS, the District must obtain sufficient funds to provide for the operation and maintenance of the services and facilities provided by the District as described in the District's budget for Fiscal Year 2018-2019; and

**WHEREAS,** the provision of such services, facilities, and operations is a benefit to lands within the District; and

**WHEREAS,** Chapter 190, Florida Statutes, provides that the District may impose special assessments on benefitted lands within the District; and

**WHEREAS,** Chapter 197, Florida Statutes, provides a mechanism pursuant to which such special assessments may be placed on the tax roll and collected by the local tax collector ("Uniform Method"); and

**WHEREAS,** notwithstanding the Uniform Method provided by Chapter 197, Florida Statutes, the District may choose other methods of collection, pursuant to Chapter 170 and Chapter 190, Florida Statutes; and

**WHEREAS**, the District has previously evidenced its intention to utilize this Uniform Method; and

- WHEREAS, the District has approved an Agreement with the Property Appraiser and Tax Collector of the County to provide for the collection of the special assessments under the Uniform Method; and
- **WHEREAS**, the District has previously levied special assessments for debt service, which the District desires to certify for collection on the tax roll for certain platted lots pursuant to the Uniform Method or directly collect for certain lands, both of which are indicated on Exhibit B; and
- WHEREAS, the District has previously levied special assessments for debt service and operations and maintenance on certain property within the District that remain unpaid and delinquent and remain subject to acceleration and/or collection efforts pursuant to Section 170.10, Florida Statutes ("Delinquent Property"); and
- **WHEREAS,** the District desires to certify special assessments for collection on the tax roll for certain platted lots and lands as indicated on Exhibit B, which reflects each lot or lands portion of the District's operations and maintenance budget for Fiscal Year 2018-2019; and
- WHEREAS, the District desires to preserve the ability to directly collect operation and maintenance assessments for prior fiscal years on the Delinquent Property; and
- **WHEREAS,** it is in the best interests of the District to proceed with the imposition of the special assessments for operations and maintenance on certain property in the amount contained in Exhibit A; and
- WHEREAS, it is in the best interests of the District to adopt the Assessment Roll of the Indigo Community Development District ("Assessment Roll") attached to this Resolution as <a href="Exhibit B">Exhibit B</a> and incorporated as a material part of this Resolution by this reference, and to certify a portion of the Assessment Roll to the County Tax Collector pursuant to the Uniform Method; and
- **WHEREAS,** it is in the best interests of the District to permit the District Manager to amend the Assessment Roll adopted herein, including that portion certified to the County Tax Collector by this Resolution, as the Property Appraiser updates the property roll for the County, for such time as authorized by Florida law.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE INDIGO COMMUNITY DEVELOPMENT DISTRICT:

**SECTION 1. BENEFIT & ALLOCATION FINDINGS.** The provision of the services, facilities, and operations as described in <u>Exhibit A</u> confer a special and peculiar benefit to the lands within the District, which benefits exceed or equal the costs of the assessments. The allocation of the costs to the specially benefitted lands is shown in <u>Exhibit B</u>.

**SECTION 2. ASSESSMENT IMPOSITION.** A special assessment for operation and maintenance as provided for in Chapter 190, Florida Statutes, is hereby imposed and levied on benefitted lands within the District in accordance with <u>Exhibit B</u>. The lien of the special assessments for operations and maintenance imposed and levied by this Resolution shall be effective upon passage of this Resolution. Moreover, pursuant to Section 197.3632(4), Florida Statutes, the lien amount shall serve as the "maximum rate" authorized by law for operation and maintenance assessments.

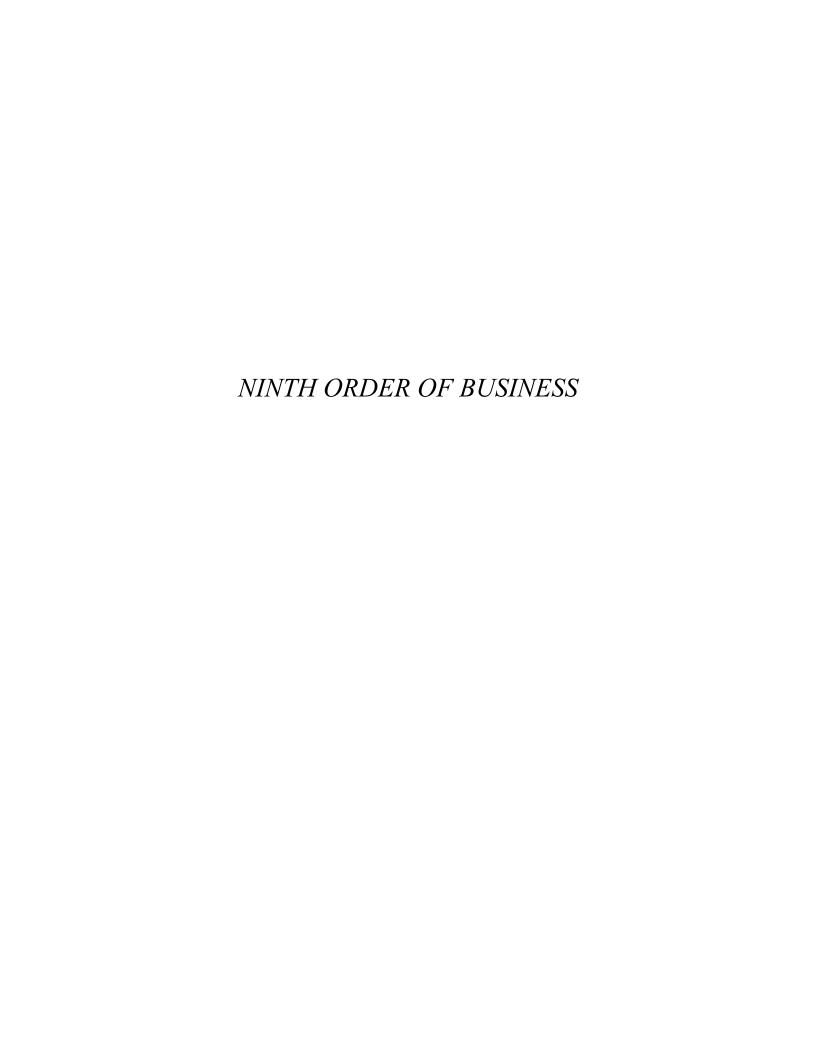
### SECTION 3. COLLECTION AND ENFORCEMENT; PENALTIES; INTEREST.

- A. The collection of the operation and maintenance special assessments for Fiscal Year 2018-2019 on certain platted lots and unplatted lands shall be at the same time and in the same manner as County taxes in accordance with the Uniform Method, as set forth in Exhibit B.
- B. The previously levied debt service assessments on lands within the District except for the Delinquent Property shall be collected at the same time and in the same manner as County taxes in accordance with the Uniform Method, as set forth in Exhibit B.
- C. This Resolution does not operate to certify for collection either the annual installment or total par amount of the previously levied debt service assessments on the Delinquent Property. The total amount of such assessments has already become due, pursuant to Chapter 170, and is already subject to collection pursuant to Florida Law. The District does not waive any of its rights or remedies with respect to the enforcement of its liens or collection of either the debt service or operation and maintenance assessments by any method authorized by Florida Law
- **SECTION 4. ASSESSMENT ROLL.** The District's Assessment Roll, attached to this Resolution as <u>Exhibit B</u> is hereby certified. That portion of the District's Assessment Roll which includes lands and certain platted lots is hereby certified to the County Tax Collector and shall be collected by the County Tax Collector in the same manner and time as County taxes. The proceeds therefrom shall be paid to the Indigo Community Development District.
- **SECTION 5. ASSESSMENT ROLL AMENDMENT.** The District Manager shall keep apprised of all updates made to the County property roll by the Property Appraiser after the date of this Resolution, and shall amend the District's Assessment Roll in accordance with any such updates, for such time as authorized by Florida law, to the County property roll. After any amendment of the Assessment Roll, the District Manager shall file the updates to the tax roll in the District records.
- **SECTION 6. SEVERABILITY.** The invalidity or unenforceability of any one or more provisions of this Resolution shall not affect the validity or enforceability of the remaining portions of this Resolution, or any part thereof.

**SECTION 7. EFFECTIVE DATE.** This Resolution shall take effect upon the passage and adoption of this Resolution by the Board of Supervisors of the Indigo Community Development District.

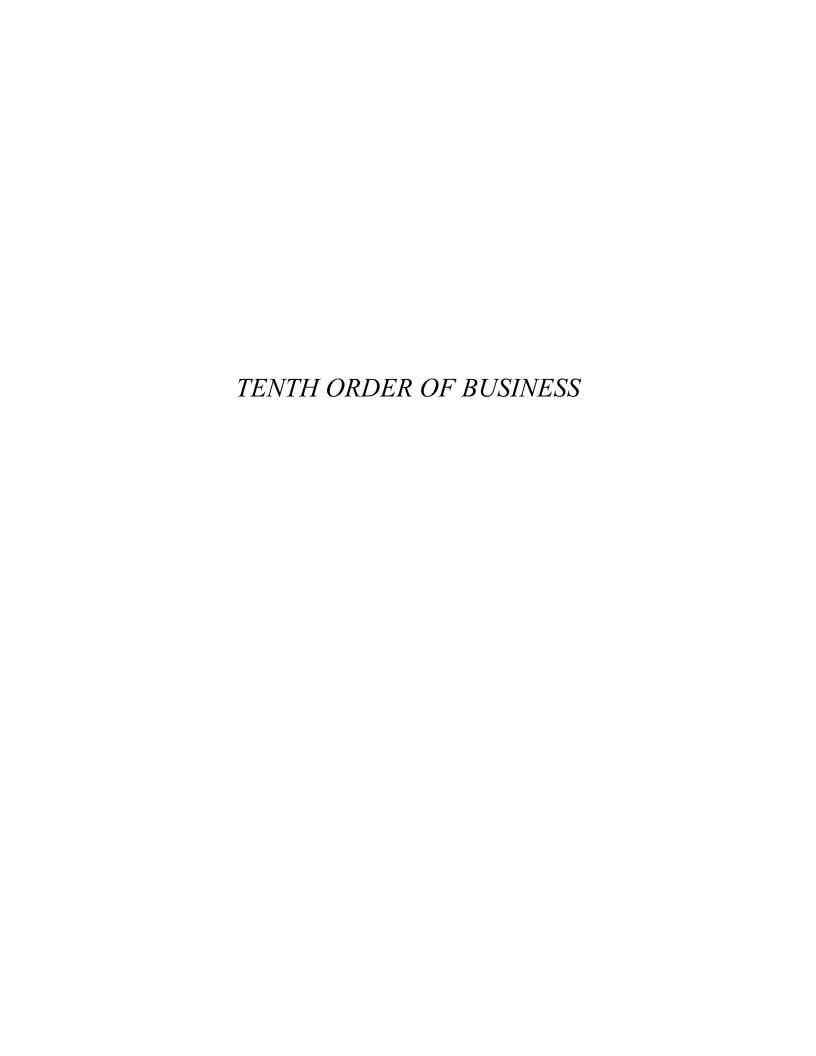

We are pleased to confirm our understanding of the services we are to provide Indigo Community Development District, Volusia County, Florida ("the District") for the fiscal year ended September 30, 2018. We will audit the financial statements of the governmental activities and each major fund, including the related notes to the financial statements, which collectively comprise the basic financial statements of Indigo Community Development District as of and for the fiscal year ended September 30, 2018. In addition, we will examine the District's compliance with the requirements of Section 218.415 Florida Statutes. This letter serves to renew our agreement and establish the terms and fee for the 2018 audit.

Accounting standards generally accepted in the United States of America provide for certain required supplementary information (RSI), such as management's discussion and analysis (MD&A), to supplement the District's basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to the District's RSI in accordance with auditing standards generally accepted in the United States of America. These limited procedures will consist of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We will not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

The following RSI is required by generally accepted accounting principles and will be subjected to certain limited procedures, but will not be audited:

- 1) Management's Discussion and Analysis.
- 2) Budgetary comparison schedule

### **Audit Objectives**

The objective of our audit is the expression of opinions as to whether your financial statements are fairly presented, in all material respects, in conformity with U.S. generally accepted accounting principles and to report on the fairness of the supplementary information referred to in the second paragraph when considered in relation to the financial statements as a whole. Our audit will be conducted in accordance with auditing standards generally accepted in the United States of America and the standards for financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, and will include tests of the accounting records of the District and other procedures we consider necessary to enable us to express such opinions. We will issue a written report upon completion of our audit of the District's financial statements. We cannot provide assurance that an unmodified opinion will be expressed. Circumstances may arise in which it is necessary for us to modify our opinion or add emphasis-of-matter or other-matter paragraphs. If our opinion on the financial statements is other than unmodified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed an opinion, we may decline to express an opinion or issue a report, or may withdraw from this engagement.

We will also provide a report (that does not include an opinion) on internal control related to the financial statements and compliance with the provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a material effect on the financial statements as required by *Government Auditing Standards*. The report on internal control and on compliance and other matters will include a paragraph that states (1) that the purpose of the report is solely to describe the scope of testing of internal control and compliance, and the results of that testing, and not to provide an opinion on the effectiveness of the District's internal control on compliance, and (2) that the report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the District's internal control and compliance. The paragraph will also state that the report is not suitable for any other purpose. If during our audit we become aware that the District is subject to an audit requirement that is not encompassed in the terms of this engagement, we will communicate to management and those charged with governance that an audit in accordance with U.S. generally accepted auditing standards

and the standards for financial audits contained in *Government Auditing Standards* may not satisfy the relevant legal, regulatory, or contractual requirements.

### **Examination Objective**

The objective of our examination is the expression of an opinion as to whether the District is in compliance with Florida Statute 218.415 in accordance with Rule 10.556(10) of the Auditor General of the State of Florida. Our examination will be conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and will include tests of your records and other procedures we consider necessary to enable us to express such an opinion. We will issue a written report upon completion of our examination of the District's compliance. The report will include a statement that the report is intended solely for the information and use of management, those charged with governance, and the Florida Auditor General, and is not intended to be and should not be used by anyone other than these specified parties. We cannot provide assurance that an unmodified opinion will be expressed. Circumstances may arise in which it is necessary for us to modify our opinion or add emphasis-of-matter or other-matter paragraphs. If our opinion on the District's compliance is other than unmodified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the examination or are unable to form or have not formed an opinion, we may decline to express an opinion or issue a report, or may withdraw from this engagement.

### **Management Responsibilities**

Management is responsible for the financial statements and all accompanying information as well as all representations contained therein. Further, management is responsible for compliance with Florida Statute 218.415 and will provide us with the information required for the examination. The accuracy and completeness of such information is also management's responsibility. As part of the audit, we will assist with preparation of your financial statements and related notes in conformity with U.S. generally accepted accounting principles based on information provided by you. These nonaudit services do not constitute an audit under *Government Auditing Standards* and such services will not be conducted in accordance with *Government Auditing Standards*. You agree to assume all management responsibilities relating to the financial statements and related notes and any other nonaudit services we provide. You will be required to acknowledge in the management representation letter our assistance with preparation of the financial statements and related notes and that you have reviewed and approved the financial statements and related notes prior to their issuance and have accepted responsibility for them. In addition, you will be required to make certain representations regarding compliance with Florida Statute 218.415 in the management representation letter. Further, you agree to oversee the nonaudit services by designating an individual, preferably from senior management, who possesses suitable skill, knowledge, or experience; evaluate the adequacy and results of those services; and accept responsibility for them.

Management is responsible for establishing and maintaining effective internal controls, including evaluating and monitoring ongoing activities, to help ensure that appropriate goals and objectives are met; following laws and regulations; and ensuring that management is reliable and financial information is reliable and properly reported. Management is also responsible for implementing systems designed to achieve compliance with applicable laws, regulations, contracts, and grant agreements. You are also responsible for the selection and application of accounting principles, for the preparation and fair presentation of the financial statements and all accompanying information in conformity with U.S. generally accepted accounting principles, and for compliance with applicable laws and regulations and the provisions of contracts and grant agreements.

Management is also responsible for making all financial records and related information available to us and for the accuracy and completeness of that information. You are also responsible for providing us with (1) access to all information of which you are aware that is relevant to the preparation and fair presentation of the financial statements, (2) additional information that we may request for the purpose of the audit, and (3) unrestricted access to persons within the government from whom we determine it necessary to obtain audit evidence.

Your responsibilities include adjusting the financial statements to correct material misstatements and for confirming to us in the written representation letter that the effects of any uncorrected misstatements aggregated by us during the current engagement and pertaining to the latest period presented are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. As part of our engagement, we may propose standard adjusting, or correcting journal entries to your financial statements. You are responsible for reviewing the entries and understanding the nature of the proposed entries and the impact they have on the financial statements.

You are responsible for the design and implementation of programs and controls to prevent and detect fraud, and for informing us about all known or suspected fraud affecting the government involving (1) management, (2) employees who have significant roles in internal control, and (3) others where the fraud could have a material effect on the financial statements. Your responsibilities include informing us of your knowledge of any allegations of fraud or suspected fraud affecting the government received in communications from employees, former employees, grantors, regulators, or others. In addition, you are responsible for identifying and ensuring that the government complies with applicable laws, regulations, contracts, agreements, and grants and for taking timely and appropriate steps to remedy fraud and noncompliance with provisions of laws, regulations, contracts or grant agreements, or abuse that we report.

Management is responsible for establishing and maintaining a process for tracking the status of audit findings and recommendations. Management is also responsible for identifying and providing report copies of previous financial audits, attestation engagements, performance audits or other studies related to the objectives discussed in the Audit Objectives section of this letter. This responsibility includes relaying to us corrective actions taken to address significant findings and recommendations resulting from those audits, attestation engagements, performance audits, or other studies. You are also

responsible for providing management's views on our current findings, conclusions, and recommendations, as well as your planned corrective actions, for the report, and for the timing and format for providing that information.

With regard to using the audit's report, you understand that you must obtain our prior written consent to reproduce or use our report in bond offering official statements or other documents.

With regard to the electronic dissemination of audited financial statements, including financial statements published electronically on your website, you understand that electronic sites are a means to distribute information and, therefore, we are not required to read the information contained in these sites or to consider the consistency of other information in the electronic site with the original document.

### Audit Procedures—General

An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements; therefore, our audit will involve judgment about the number of transactions to be examined and the areas to be tested. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. We will plan and perform the audit to obtain reasonable rather than absolute assurance about whether the financial statements are free of material misstatement, whether from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations that are attributable to the government or to acts by management or employees acting on behalf of the government. Because the determination of abuse is subjective, *Government Auditing Standards* do not expect auditors to provide reasonable assurance of detecting abuse.

Our tests, if performed, will be less in scope than would be necessary to render an opinion on internal control and, accordingly, no opinion will be expressed in our report on internal control issued pursuant to *Government Auditing Standards*.

An audit is not designed to provide assurance on internal control or to identify significant deficiencies or material weaknesses. However, during the audit, we will communicate to management and those charged with governance internal control related matters that are required to be communicated under AICPA professional standards and *Government Auditing Standards*.

### **Audit Procedures—Compliance**

As part of obtaining reasonable assurance about whether the financial statements are free of material misstatement, we will perform tests of the District's compliance with the provisions of applicable laws, regulations, contracts, agreements, and grants. However, the objective of our audit will not be to provide an opinion on overall compliance and we will not express such an opinion in our report on compliance issued pursuant to *Government Auditing Standards*.

### **Engagement Administration, Fees, and Other**

We understand that your employees will prepare all cash or other confirmations we request and will locate any documents selected by us for testing.

The audit documentation for this engagement is the property of Grau & Associates and constitutes confidential information. However, subject to applicable laws and regulations, audit documentation and appropriate individuals will be made available upon request and in a timely manner to a cognizant or oversight agency or its designee, a federal agency providing direct or indirect funding, or the U.S. Government Accountability Office for purposes of a quality review of the audit, to resolve audit findings, or to carry out oversight responsibilities. We will notify you of any such request. If requested, access to such audit documentation will be provided under the supervision of Grau & Associates personnel. Furthermore, upon request, we may

Our fee for these services will not exceed \$5,000 for the September 30, 2018 audit, unless there is a change in activity by the District which results in additional audit work or if Bonds are issued.

The audit documentation for this engagement will be retained for a minimum of five years after the report release date. If we are aware that a federal awarding agency or auditee is contesting an audit finding, we will contact the party(ies) contesting the audit finding for guidance prior to destroying the audit documentation.

Our invoices for these fees will be rendered each month as work progresses and are payable on presentation. Invoices will be submitted in sufficient detail to demonstrate compliance with the terms of this agreement. In accordance with our firm policies, work may be suspended if your account becomes 60 days or more overdue and may not be resumed until your account is paid in full. If we elect to terminate our services for nonpayment, our engagement will be deemed to have been completed upon written notification of termination, even if we have not completed our report. You will be obligated to compensate us for all time expended and to reimburse us for all out-of-pocket costs through the date of termination. The above fee is based on anticipated cooperation from your personnel and the assumption that unexpected circumstances will not be encountered during the audit. If significant additional time is necessary, we will discuss it with you and arrive at a new fee estimate.

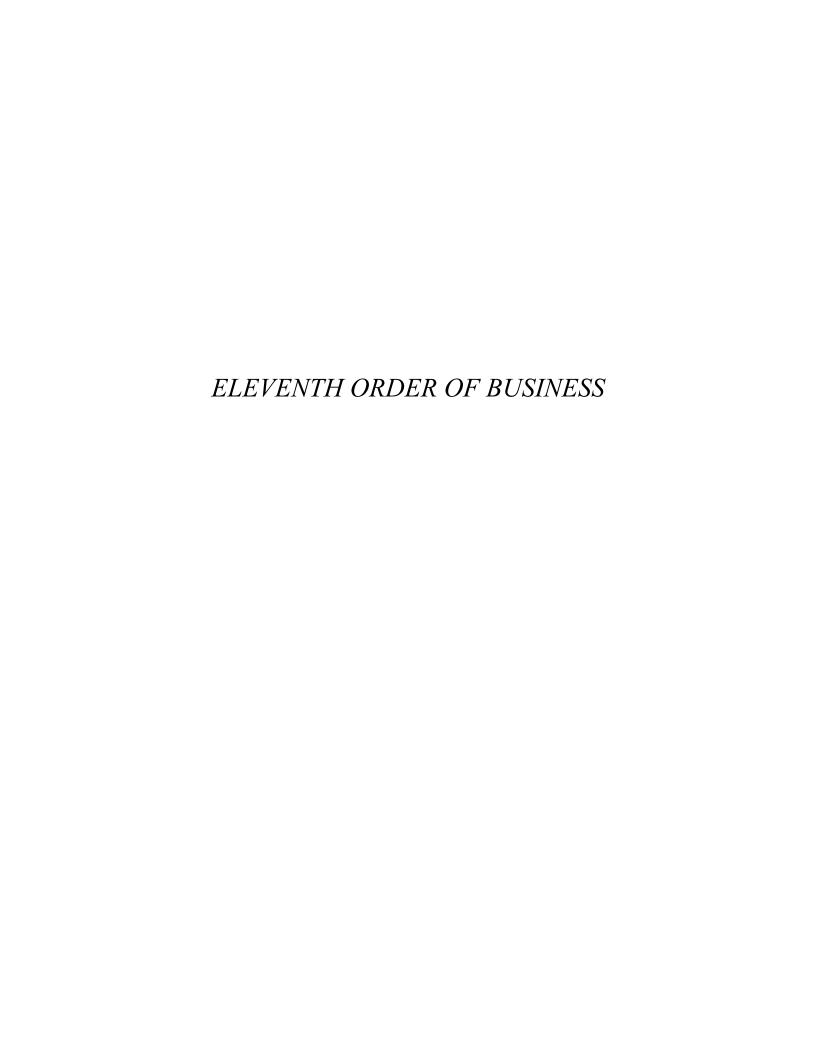

### FIRST ORDER OF BUSINESS Roll Call

Mr. Leek called the meeting to order and Mr. Perry called the roll.

### SECOND ORDER OF BUSINESS Audience Comments

Mr. Mitchell Brent stated I am here to address the installation of pocket parks in LPGA. I understand the board's concern about the ability to restrict sex offenders in the LPGA community, however we would like to investigate alternatives instead of assuming the liability that we pass on to our residents through building these parks. We contacted our legal counsel to address the covenants and restrictions to prohibit sex offenders. We cannot agree to the installation of parks in our community, the members I have talked to have not been receptive. Before the board spends money to build these little parks we should have a meeting among the boards of all the communities.

THIRD ORDER OF BUSINESS

Approval of the Minutes of the May 23, 2018 Meeting

On MOTION by Mr. Parks seconded by Mr. McCarthy with all in favor the minutes of the May 23, 2018 meeting were approved as presented.

# FOURTH ORDER OF BUSINESS Discussion of Hayman Wood Delinquent Properties

Mr. Perry stated the board considered at the last meeting a proposal for a settlement agreement on a number of parcels that Cardinal Servicing Co. owns and we reviewed with the board the past due O&M and debt service related to those parcels. They were also at that time looking to acquire two additional parcels and they are still in the process of doing that. This settlement agreement covers the 11 parcels that were discussed in detail and the two other parcels that weren't discussed with the board in detail at the last meeting. The concept for the two additional parcels is the same as the other 11 in regard to the district waiving the interest and penalties associated with the past due O&M. You have a copy of this in front of you and there are some notations for corrections of dollar amounts and they are all related to the two additional parcels. The amounts they have reflected in their proposal did not fully contemplate all the direct bills that were sent to one of the parcels that related to the 2011 timeframe for a couple of years. We are working through that with them, they had not requested estoppel letters on those two parcels until about a week and a half ago so working through that the numbers are a little bit different than what they have proposed.

As you can see there is a settlement agreement proposed most of it relates to the bonds and the structure of the bonds is somewhat similar to what they asked the district, which was the waiver of penalties in regard to those bonds. Although payments were made there is interest that does fall on those bonds for the time certain. At the last meeting the board was pretty adamant that they wanted something back to the board within a 30-day timeframe so as to not drag on. The feedback I have gotten from them is that they have had very good discussions with the bondholders and it appears they will move forward with this concept that has been presented but it has not been signed as of today.

Mr. Leek asked how long do you think getting bondholder approval will take? Is this something they want to get rid of right away?

Ms. Buchanan stated yes, I think trustee's counsel was on vacation and when I talked to Mr. Artin, who represents the purchaser of the land, said he has been calling a couple times a

week. He still does not have any indication that there is something wrong with the deal it is just not a priority of the lawyer.

Mr. Leek stated that was really my question, how the bondholders feel, are they in any hurry.

Ms. Buchanan stated it is hard to say.

Mr. Leek stated we talked earlier that this amount is not really that big of a deal, to the bondholders.

Mr. McCarthy stated in the minutes it indicated that interest on the tax certificates had been paid, about \$222,000. Looking on page 3 with these numbers, it indicates that \$52,000 is outstanding.

Mr. Perry stated correct. The \$222,000 is the amount of interest paid in relation to the 11 parcels. I don't have the amount of interest received on the two parcels from Volusia County.

Mr. Parks stated one of those parcels was reallocated to far more parcels that what is on the original.

Mr. Perry stated correct if you will remember one parcel was approximately 400+ acres and was originally thought to be all wetlands and is why it has such a strange shape and when England Thims & Miller did their study a lot of that land was determined to be buildable and probably wouldn't qualify as wetlands with uplands. Originally there was only about 35 units allocated to that and the reallocation reflected about 680 units.

Ms. Buchanan stated from my understanding the amount they reference, the \$450,000, this relates to what was just 30 units?

Mr. Perry stated when we redid the reallocation we didn't bill for a number of years.

Ms. Buchanan stated I did talk to Ken about this number and whether or not the additional parcels could be included in the settlement agreement. We are still reviewing it to ensure that we have given them the right information and they can make their decision as to whether or not they can swing it. He is trying to work with his client to investigate what their levels of tolerance are, but I do think \$450,000 is what they are able to do. When we talk about the agreement today I think we should probably still delineate the two Cardinal pieces versus the additional parcels.

Mr. Perry stated the 11 parcels they own.

Mr. Leek asked will it be a separate agreement for the other two?

Ms. Buchanan stated if the number stays at \$450,000 we need to take \_\_\_\_\_\_\_ of the settlement agreement since we don't know what the number is today.

Mr. Perry stated I think what we would be asking the board to do today is to consider extending the settlement offer.

Ms. Buchanan stated that is definitely one option. Alternatively, we could approve the settlement agreement as to the Cardinal parcels if you are comfortable with that and then our decision on the additional parcels. You have two options. You can continue the meeting because I do think they want to try to see resolution or you could delegate authority to someone to negotiate a final deal and bring back a final form. I did tell Mr. Artin that given that you are all residents that may not be the option you prefer so a continuance might be an option.

Mr. Leek asked would it make sense for us to separate them right now and approve the 11-parcel agreement that was voted on last month and then develop a new one for the two parcels?

Mr. Parks stated I would favor that approach to come to a settlement on the 11 parcels that we talked about at the last meeting. Then if this process for the other two can be expedited we could call a special meeting and go ahead and do it.

Mr. Perry stated maybe you bifurcate them and approve the 11 and maybe the other 2 you approve under the same conditions in case these numbers go down, if they do go down you would be providing them the same relief and maybe we wouldn't have to have another meeting under the same parameters.

Mr. Leek asked the numbers that are penciled in here?

Mr. Perry stated yes.

Ms. Buchanan stated what you are saying not necessarily tied to this number but more on what are the actual amounts of outstanding O&M assessments that would be paid that would not be charged interest and penalties.

Mr. Perry stated that is correct.

Ms. Buchanan stated I have a resolution that goes into the history, identifies that we issued two series of bonds, that we had delinquent O&M and debt assessments and it makes a determination that Cardinal wants to settle and we think it is important to settle because it is in the best interests of the district to continue development of the project. Section three specifically authorizes the execution and delivery of a settlement agreement in substantial form, meaning this

isn't the final form, we authorize the chairman to execute the final form, assuming that he wouldn't sign off on it without any input from the staff and it is in line with the parameters you discussed today.

This is in substantial form as to the settlement agreement. Specifically, we understand there may be some changes in section three as it relates to the additional parcels, but the board is comfortable generally with accepting payment for the O&M assessments in essentially the same terms that would be applied to the other parcels meaning without penalties and interest.

Mr. McCarthy stated let's say that the same thing happens with the two additional parcels. Is there anything we can have in writing in the agreement that it would revert back to where we are today?

Ms. Buchanan stated I think under the parameters in the resolution if we were to take out the language relating to the two parcels completely we could still move forward with the 11.

Mr. Perry stated those dollars stay there until they settle with us so if they for some reason sign it and don't pay us again, it remains there.

Mr. Leek stated this is all subject to the bondholders reaching agreement.

Mr. Perry stated correct.

Ms. Buchanan stated I'm going to modify the language in section eight because it says this resolution becomes effective upon adoption by the district, but I think you want to say, adoption by the district and execution by the bondholders.

On MOTION by Mr. Parks seconded by Mr. McCarthy with all in favor Resolution 2018-02 was approved.

Mr. Welsh joined the meeting by telephone during this item.

# Discussion of the Fiscal Year 2019 Budget

Mr. Perry stated we have this as a placeholder, we haven't made any changes to the budget that was presented last month and we will adopt that in August.

#### SIXTH ORDER OF BUSINESS

Mr. von der Osten stated there are no changes from the last RFP. The contract with Rountree does expire September 30<sup>th</sup> and the proposed schedule would allow us to meet all required timeframes.

#### SEVENTH ORDER OF BUSINESS Staff Reports

## A. Attorney – Discussion of Recreation Powers of CDDs

Ms. Buchanan stated we were going to circle back to you about recreation powers of CDDs. This particular district was established by FLAWAC so it went to the state for establishment and did not go through the City of Daytona Beach. Nothing in my records is telling me that we actually have recreation powers. We are not currently authorized to have parks or amenity centers. We can go the city and request that, it is generally a couple thousand dollars.

Mr. Perry stated this district was created in the 1990s and districts created in the 2000s that is a standard provision when you create districts and you have to request it. It wasn't requested when this one was formed.

- Ms. Buchanan stated it wasn't part of our improvement plan.
- Mr. Leek asked how does that impact what Grand Champion wants to do?
- Ms. Buchanan stated if the HOA doesn't fund it we can't.
- Mr. Leek asked do you have any insight into the associations?
- Mr. von der Osten stated right now it is a mixed bag. Rennar is up in the air about it, two HOAs are in favor of it. The others are waiting to see what happens.
  - Mr. Leek stated the two in favor are the proposed spots are on HOA land?
- Mr. von der Osten stated yes. They could go ahead and they have asked if we go ahead and put in the park and the CDD came in later and approves this when would we be eligible to submit for those funds?
  - Mr. Leek asked can we contribute to the park being built by the HOA?
- Mr. Perry stated you are not going to own it and you not acquiring it and you are not utilizing bond funds it would be out of the general fund so you could probably could do it.
- Ms. Buchanan stated you don't have recreation powers. I think Jim is right since you are not utilizing bond proceeds that would remove some of the restrictions.

Mr. Leek asked is our message today when Kurt talks to these folks to tell them they can do it but we can't? The reason we have this on the table is because some HOA came to us wanting us to put it in.

Ms. Buchanan stated the one item that you have to take into account is that your money comes from people within the entire community so if you give it to an HOA and then the users are restricted to residents of that HOA I think that might be a problem. Would the HOA be willing to accept it with strings attached that every resident could come?

Mr. von der Osten stated you could go ahead with this and use your funds for this but there is no guarantee that the CDD could contribute in the future. You just have to keep that in mind.

Mr. Leek asked is that basically like the resolution going to the city?

Mr. Perry stated the city will have to have a hearing on it and approve it.

Ms. Buchanan stated the last one we did in Poinciana took about 8 hours excluding travel time as far as paperwork and communications.

Mr. Leek stated the \$2,000 for the fee plus your legal costs, right?

Ms. Buchanan responded give or take, these are estimates. I think \$5,000 is a safe number.

Mr. Parks stated based on that cost I think if the individual associations have the power we don't need it.

Mr. Mitchell Brent stated when this was brought to us to consider I started looking at alternatives and based on the current case law a community can restrict residents to an extent and we are dealing with one specific class of individuals who are sex offenders or sexual predators. In 2004 the legislature had a statute that said 1,000-foot radius from parks, daycare, schools and places where children would congregate. The City of Daytona Beach enacted an ordinance in 2011 and extended the radius to 2,500 feet. I do believe there is an HOA that amended their C&Rs to make it 3,000 feet from any school bus stop. We can amend our C&Rs for the Rennar LPGA HOA to exclude sex offenders from those areas and the only cost would be our HOAs cost for our legal counsel and presented it our community and our voting members. There would be no residual on the cost, no increase in HOA dues, there would be no need to worry about insurance and maintenance and upkeep and repair as long as we have school bus stops in the neighborhood.

Mr. Leek asked are you discussing this with the other associations?

Mr. Brent responded no. We were supposed to have had a meeting with some of the other associations. They can do a park by their pool but that is their expense and their cost and they would have the benefit of having a park that the sheriff's office, law enforcement and department of corrections would know to extend the radius. Anybody living in the area would be grandfathered in. They can do that on their own property. We are not in a position to go to our residents and say we are going to raise your dues to build parks in the community to keep sex offenders out. We have discussed it in-house already, we are on the same page it is a matter of getting the verbiage together and presenting it to our board of directors to approve.

Mr. Leek stated based on what you are saying it sounds like this is an individual HOA issue. It doesn't sound like we have a lot to do with it, in spite of the fact that we don't have the authority anyway.

Ms. Buchanan stated Kurt, just to clarify, the city attorney you are working with he actually did this through an HOA not a CDD.

Mr. von der Osten stated correct.

Ms. Buchanan stated I want to point that out because CDDs are a government entity and they do have more scrutiny as to their actions as opposed to an HOA that is a private entity.

Mr. Leek stated those are my thoughts I think we need to take a step back on this and see what happens with the associations.

Mr. Parks stated what you are saying Katie is if we wanted to give some money to Grand Champions we could give it, this is for discussion purposes, \$2,000. That would be permitted.

Ms. Buchanan stated you are not restricted because you are not using bond proceeds, you are using general fund money, which as long as it is provided by use by the entire community I think you would be okay. The question is even more broad, could you just give them an unfettered \$2,000 for community improvements and let them dictate how they choose to use it while you understand they probably will use it as a park then you are absolutely not exerting your own power, you have no tie to recreation. I think it is a pretty tenuous stretch to say a donation of capital to an HOA is an exertion of rec powers.

Mr. Leek stated it looks like an easier path is the HOAs to do it.

Mr. McCarthy stated I know there is an effort to get the HOAs together in July sometime and I suggest we table this until they get together.

Mr. Leek stated I know my neighborhood is not interested in having a park.

On MOTION by Mr. McCarthy seconded by Mr. Parks with all in favor the issue of parks was tabled.

## B. Engineer

There being none, the next item followed.

## C. Manager

Mr. Perry stated we are in the process of doing enhancements to the CDD website to make it more accessible by people with disabilities. We have tried to get quotes from various vendors to do that. We have one quote now and it is probably going to be about \$10,000 to \$15,000. I can talk to you individually but it is something you need to do because there has been some litigation on it already with governmental entities. If there are pictures on the website you have to have that picture described to someone who is blind. There is lot of conversion work that needs to be done.

By statute you are required to have certain documents on your website and this district like several of our districts have a lot more public information than what is required. We have gone way above the minimum standards. What we will probably end up doing is recommending that we go to the minimum for cost reasons so there will be less information rather than more.

Mr. Leek asked what else other than pictures that need to be verbalized? Does the whole thing need to be verbalized?

Mr. Perry stated it is the format of the documents that are currently on the website. They have to be converted to documents that allow programs that will do the transcription. The documents we currently have in place some may be transcribable, the bulk of them are not. Transcribe them so they are available for these special types of programs that are not inexpensive. As a stopgap measure we have on there that if you have problems accessing the site please call us.

Mr. Parks asked will you come back to us with a more concrete proposal?

Mr. Perry responded yes.
