FIRST ORDER OF BUSINESS

Roll Call

Mr. Perry called the meeting to order and called the roll.

SECOND ORDER OF BUSINESS

Audience Comments

A resident stated we are having an issue with homeless people who are now camping out in the property northeast of Acclaim going down towards Rountree's workshop area. I don't know if it would be the master association or the CDD who would enter into an agreement with the City of Daytona Beach to have it posted as no trespassing.

Mr. Perry stated if it is not a district property we have no authority over it.

Ms. Buchanan stated it is private property and I believe it is in the process of being transferred and I'm happy to pass along the message to the attorney we are working with to see if he can get some signage posted.

A resident stated we had that issue a few years ago and they were in the protected turtle area and they chased them out.

Mr. Rountree stated I have a meeting Friday at the police station and I will get with the chief and get some new signs from him. We will update the current post and as long as the board authorizes a few dollars it takes to buy the lumber we can get it built we can get new ones on the conservation area too.

Mr. Perry stated we need to notify because there is a change in ownership of that parcel.

Mr. Leek asked how many people are we talking about living back there?

Mr. von der Osten stated they come and go, I have walked the site twice inspecting it and never ran into anybody but there are indications that they have been in there. There is clothing, food containers and things of that nature.

THIRD ORDER OF BUSINESS

Affidavit of Publication

A copy of the affidavit of publication of the public hearing was included in the agenda package.

FOURTH ORDER OF BUSINESS

Ratification of Agreement with Cardinal Servicing Company, LLC

Mr. Perry stated item four is ratification of agreement with Cardinal Servicing Company, LLC. We received confirmation that they did wire in the \$259,520.24 related to the 11 delinquent parcels. If you will recall that was the agreement the board approved a couple months ago. It had been modified slightly, none of the major parameters have changed since your approval, however, it did take some time to get it all closed and worked out.

Ms. Buchanan stated there was a bondholder issue, not an O&M issue that they had to work out.

Mr. McCommon stated that is the O&M but did they submit the other part?

Mr. Perry stated they submitted the portion due to the bondholders to them. They are current on all their property taxes in regard to those parcels.

Mr. McCommon stated we have already had tax certificates on everything there.

Mr. Perry stated correct. When we get to the fiscal year budget 2019 we have taken that into consideration and as a result you will see what we are proposing for adjustments to assessments for next fiscal year.

I had the chair sign the agreement a couple weeks ago, there have been no major modifications and I would like you to ratify that agreement.

On MOTION by Mr. Parks seconded by Mr. McCommon with all in favor the settlement agreement with Cardinal Servicing Company, LLC was ratified.

Ms. Buchanan stated it is in the agreement but just to point it out to you, you had the 11 parcels included, which have been resolved. They still are hoping to resolve two more additional parcels, which would be NW 13 and 15 and NW 21 and 22 and that is contained on their list and the satisfaction will be released upon payment.

Mr. McCommon asked are they still negotiating on that?

Ms. Buchanan stated again with the bondholder. The way it works is that somebody probably owns 80% of these bonds and somebody else owns 5-10%

FIFTH ORDER OF BUSINESS

Ratification of Satisfaction and Release of Notices of Unpaid Non-Ad Valorem Special Assessments

Mr. Perry stated associated with the above item we also ask that you ratify the satisfaction and release of notices of unpaid non-ad valorem special assessments related to those parcels.

On MOTION by Mr. Parks seconded by Mr. McCommon with all in favor the satisfaction and release of notices of unpaid non-ad valorem special assessments were ratified.

SIXTH ORDER OF BUSINESS

Discussion of Settlement of Past Due O&M Assessments on SW 30

Mr. Perry stated associated with Cardinal Servicing Company they have been looking at SW30. I included that in your agenda package because we did provide them an estoppel letter. If you will recall SW30 is the parcel I refer to as kind of an amoeba, it is on the south end and goes for several acres and there are approximately 681 lots that were associated with that. Originally, several years ago that parcel was described as mostly wetlands and when we did the review with England-Thims & Miller they determined it was a combination of wetlands but there was a lot of developable land within that parcel. With that, we adjusted the debt that was allocated to that parcel. As a result of that at this point in time there is approximately \$740,000

worth of O&M with penalties and interest on that parcel and the earlier communications from Cardinal is that they are not going to be able to develop that type of number of units and they are looking for some type of relief from the board in regard to O&M and also they are working with the bondholders. We have told them we would inform the board of that because we have asked them where they are going with this and what do they think in regard to the number of units. I just wanted to let you know that parcel is in play also. There are a lot of Hayman Wood parcels that are starting to come to be more desirable for the marketplace.

Mr. Leek asked did they indicated any kind of a timeframe of when they might know what they want to do?

Ms. Buchanan stated I think our last email from Ken was yesterday so they are actively trying to work on something right now.

Mr. Leek asked they are not speculating on what they think are the buildable lots?

Ms. Buchanan stated that is a good question for you. What kind of information would make you comfortable evaluating the number of buildable lots? Ken will ask Jim and I, what do you think about an appropriate number and Jim is correct in saying it is not our job to negotiate against the board, you have to help.

Mr. Leek asked would it be appropriate to go back to the engineer and say this is what you said six years ago?

Ms. Buchanan stated the individual who did the report for us passed away, his company is still in existence so we could certainly do that. At the same time I'm sure they have an engineer that could provide information as well.

Mr. McCommon stated they would have to come back with a proposal and say we think there are only 500 lots and here is our offer. I am interested in what they have to say but give us a number.

Mr. Parks stated if they gave a ridiculously low number then we might want to get an engineer.

Mr. Perry stated I don't want to negotiate against ourselves.

Mr. Leek stated we have a documented number and we know where we are. We just need to know where they are so we can see if we can meet somewhere in between.

Mr. McCommon stated not only do I want to hear the number of lots but why it is different.

SEVENTH ORDER OF BUSINESS

Discussion of Hayman Wood Delinquent Properties

Mr. Perry stated we will remove this item from future discussions because the parcels are now turning over.

EIGHTH ORDER OF BUSINESS

Public Hearing to Adopt the Budget for Fiscal Year 2019

A. Consideration of Resolution 2018-03 Relating to Annual Appropriations and Adopting the Budget for Fiscal Year 2019

Mr. Perry stated you will notice in almost all the categories we kept expenses relatively flat and in regard to assessments in the prior year we used approximately \$109,000 of excess funds to lower assessments and this year we are proposing to use \$300,000 to lower assessments. We have two types of assessment units, one being platted lots and all the units in the north section whether they have been platted or not are treated as platted lots. In the north section there are approximately 1,445 and in the south there are 466 lots that are platted. Those are all treated the same and then there are approximately 3,000 unplatted units that are raw land in the south. The assessments for the north parcels and the platted units in the south last year were \$383 this year we are proposing that they be \$300.93 so you are going to have about an \$82 reduction in the assessments for O&M. Likewise the unplatted lands in the district in the south will be treated such that the \$103 per unit will go down to about \$75. Taking that into consideration you will see on page 3 of the budget the cash the district has on hand that we are predicting at the end of the year is approximately \$2.9 million. You have adequate cash on hand to utilize that \$300,000.

Mr. Leek asked how many times have we reduced the assessments?

Mr. Parks stated this is the third year in a row isn't it?

Mr. Perry stated yes.

Mr. McCommon stated when these lots become platted some of this related to the acquisitions their O&M portion is going to go up.

Mr. Perry stated if they are in the south.

Mr. McCommon stated that could also result in the lowering of everyone's O&M as well.

Mr. Perry stated correct, as long as overall general costs don't increase.

On MOTION by Mr. Leek seconded by Mr. McCarthy with all in favor the public hearing was opened.

Mr. Perry asked are there any comments or questions from the public?

There being none,

On MOTION by Mr. Parks seconded by Mr. McCarthy with all in favor the public hearing was closed.

Mr. Perry stated Resolution 2018-03 is the appropriation resolution and on page 2 of that we are going to insert these numbers based upon the budget. The total general fund will be \$1,110,679, the 1999A Bond funds would be \$81,550, the 1999C Bond funds would be \$301,980, and the series 2005 would be \$87,804 for a total of \$2,316.013.

On MOTION by Mr. McCommon seconded by Mr. McCarthy with all in favor Resolution 2018-03 was approved.

B. Consideration of Resolution 2018-04 Imposing Special Assessments and Certifying an Assessment Roll for Fiscal Year 2019

Mr. Perry stated next is Resolution 2018-04 imposing special assessments and certifying an assessment roll. Based upon the adopted budget we will take those numbers and adjust the roll to the county and that will take place this year and be on your next tax bill. You will recognize that reduction in assessments.

On MOTION by Mr. Leek seconded by Mr. McCarthy with all in favor Resolution 2018-04 was approved.

NINTH ORDER OF BUSINESS

Consideration of Landscape Maintenance Proposals

Mr. Perry stated item nine is consideration of landscape maintenance proposals and we provided by email and there is a hard copy in front of you, staff's ranking of the proposals. There were three proposals received, Rountree, Yellowstone and Millenium. There was an additional proposer that provided a packet late that we did not accept. We have gone through and ranked these. Personnel, experience, understanding scope of work and financial capability

are all subjective. The price is a formula computation where Rountree, which was the lowest bidder received the full 15 points and Yellowstone based on their pricing received 13 points and Millenium received 11 points. In regards to ranking and personnel Rountree and Yellowstone were basically the same, Millenium was a little less. Experience, again sort of the same track, Rountree, Yellowstone max points and Millenium a little less. Understanding scope of work obviously Rountree understands the needs of the community and has been doing it for a long time and they received 25 points the others received 22 points. Financial capability Rountree and Yellowstone are very close and Millenium was just a little lower. We ranked Rountree no. 1 with 99 points, Yellowstone no. 2 with 95 points, and Millenium no. 3 at 90 points. Before we can adopt this if you have different rankings, the important thing is how you rank them 1, 2, and 3. We will enter into negotiations with the number one ranked firm and if that doesn't work out then go to no. 2.

Mr. Leek stated I agree with staff's ranking and I'm willing to make the motion.

Mr. McCommon asked are we limited to a three-year contract?

Ms. Buchanan stated I think our rules of procedure do limit us to a three-year contract.

Mr. Perry stated unfortunately, it is pretty much an industry standard. It is a lot of work, it takes a lot of time for staff to do this every three years. I will check but I believe it is three years.

Mr. McCommon stated I just wondered if every five years was a possibility. As part of that research can you find out if you are allowed to have a renewal automatically at the end of the three years with one-year renewals to make it up to five years. I know when I have gotten involved with municipal contracts in the past they had something like that and it was up to their discretion to renew it.

Mr. Perry stated we will look to see if we can tack that on.

On MOTION by Mr. Leek seconded by Mr. Parks with all in favor the ranking as presented was adopted and Rountree was ranked no. 1, Yellowstone no. 2 and Millenium no. 3.

TENTH ORDER OF BUSINESS

Acceptance of the Engagement Letter with Grau & Associates for Preparation of the FY 2018 Audit Report

Mr. Perry stated if you remember we contracted with Grau & Associates and their audit fee is consistent with their proposal and we are asking the board to accept their engagement letter to get started for fiscal year 2018.

On MOTION by Mr. Leek seconded by Mr. McCarthy with all in favor the engagement letter with Grau & Associates to perform the fiscal year 2018 audit was approved.

ELEVENTH ORDER OF BUSINESS

Approval of the Minutes of the June 27, 2018 Meeting

On MOTION by Mr. Parks seconded by Mr. Leek with all in favor the minutes of the June 27, 2018 meeting were approved as presented.

C. Manager – Discussion of Fiscal Year 2019 Meeting Schedule

On MOTION by Mr. McCarthy seconded by Mr. McCommon with all in favor the board will hold their meetings for fiscal year 2019 at 1:00 p.m. at the Holiday Inn Daytona Beach on the following dates: October 24, 2018, November 28, 2018, January 23, 2019, March 27, 2019, May 22, 2019, June 26, 2019, August 28, 2019 and September 25, 2019.

D. Field Operational Manager – Proposal for Signage Improvements (CTLC to fund 50%)

Mr. von der Osten stated we have a proposal from Consolidated Tomoka to update the entry monument signs and this is replacing the interior panels, the blue panels that are currently

there, with the new logo and refreshing all the entry signs and they will contribute 50% of the cost. The total cost is \$34,222 and the district is paying \$17,111.

Mr. McCommon stated it seemed like the old signs really needed quite a bit of maintenance every year. Are these signs going to weather better?

Mr. von der Osten stated all signs over time are going to need some maintenance. This is faux stone behind it.

Mr. McCommon stated if it is faux stone it won't need to be painted.

Mr. von der Osten stated it is not a large surface so over time a cleaning will be needed.

Mr. McCommon stated the sign at the clubhouse when you are coming in off International Golf Drive there was a newer type logo but it isn't this. I'm wondering should that not be included.

Mr. Leek stated probably not in what they are proposing, it is not us. I am assuming they will have that one match.

Mr. Parks stated it is interesting that they won't split the cost.

Mr. Leek stated I like this proposal, I like the signs, I think they look good and I don't have any problem with us contributing to the project. We maintain the signs. I believe the logic we had before where we wanted Consolidated to make the changes was because they had changed the logo and other things like that going on. Now I think the signs are 20+ years old and need to be updated with something a little more current.

Mr. Parks stated I would like to see something that says they would also contribute to the yearly maintenance of the signs, 50%.

Ms. Buchanan stated realistically if you think it makes your community look better that is probably the most important thing.

Mr. Parks stated there is no question the signs are an enhancement.

Mr. McCommon asked the one on Champions that says, restaurant and golf, is that going to say, welcome only, now?

Mr. Leek stated there is another one that says golf course, restaurant.

Ms. Buchanan stated they are not offering us approval of the signs, they are just requesting a contribution.

Mr. von der Osten stated correct.

Mr. McCommon stated I would like consideration of a different font, something a little nicer.

Ms. Buchanan stated as a board action item you would decide whether you are willing to contribute and whether that contribution is contingent on approval.

Mr. Leek stated that is more than fair and we are willing to contribute half to make the neighborhood look better but we would like to have some sort of final approval, we don't want any design tasks, we just want approval.

Mr. Parks asked what about the maintenance?

Mr. Leek stated I think maintenance is pretty minimal. We have them pressure washed every once in a while. We repainted it once in 22 years.

Mr. Parks stated I would be willing to support it and maybe that is a step in healing their past differences.

Ms. Buchanan stated I think ultimately it looks nice.

Mr. Leek stated I don't want to get into design and they have skin in this game too. There are 700 different fonts and we can get into deep discussion on that kind of stuff. I trust them to put up a nice looking sign and it would be a lot of work and problems for us to try to get involved in the design and it could sour the relationship. I would like to approve this and have Kurt go back and say we would like to see the final proof before production if we can do that within our meeting schedule. I like the ones they have shown us and I trust them to pick the best one and if we get involved it is just going to drag it out.

On MOTION by Mr. Leek seconded by Mr. Parks with all in favor the proposal for signage improvements in the amount of \$34,222 with the district responsible for 50% not to exceed (\$17,111) and CTLC responsible for 50% was approved.

Mr. von der Osten stated we have a request from the manager of the Jubilee HOA to clean out the sod along their hedge line along Champions Boulevard at Tournament.

Mr. McCommon stated they cut the hedges way back and they want us to put in sod.

Mr. Leek stated this is where they had hedges dying. The argument was over whether it was CDD responsibility or the HOA. The plat clearly showed it was HOA property. After a lot of discussion I negotiated with them over several weeks and agreed there were certain sections

Mr. McCommon responded no. I just want to know where and how we are going to see that reflected down the road.

Mr. Perry stated they brought everything current in regard to these parcels.

Ms. Buchanan asked in the final copy of the agreement did they attach the amortization schedules?

Mr. Perry stated yes.

Ms. Buchanan stated I think that is the answer to your question. We can provide you amortization schedules for each of the parcels to reflect the write-off of interest and this amount of principal.

Mr. McCommon stated we shouldn't have a negative fund balance.

Mr. Perry stated we will.

Ms. Buchanan stated unfortunately that is from the expenditure of the debt service money on things like litigation and trustee's counsel.

Mr. Perry stated there is an impact but there are still all these other parcels out there that are still delinquent. Going forward our assessments related to the debt service funds will start to go out and we will be able to pay bondholders because they are performing assets.

Mr. Leek stated that doesn't really affect our financials.

Mr. Perry stated indirectly, for the bondholders in essence.

A resident asked is there anything further on the playgrounds you talked about a few months ago?

Mr. von der Osten stated we took it off the table for the time being.

FOURTEENTH ORDER OF BUSINESS Approval of Check Register

On MOTION by Mr. Parks seconded by Mr. McCarthy with all in favor the check register was approved.

FOURTH ORDER OF BUSINESS

SETTLEMENT AGREEMENT

THIS SETTLEMENT AGREEMENT (this "Agreement") is made and entered into effective as of the ___th day of September, 2018 (the "Effective Date"), by and between SW-30 INVESTMENTS LLC ("American"), a Florida limited liability company, INDIGO COMMUNITY DEVELOPMENT DISTRICT, a local unit of special purpose government (the "District") duly organized and existing under the provisions of the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, as amended (the "Act") and U.S. BANK NATIONAL ASSOCIATION, a national banking association, as Trustee (the "Trustee"). In this Agreement, American, District and Trustee are hereinafter sometimes referred to separately as "Party" and collectively as "Parties".

RECITALS

A. The District is a local unit of special purpose government duly organized and existing under the provisions of the Act, by rule of the Florida Land and Water Adjudicatory Commission effective January 3, 1995, and is validly existing under the Constitution and laws of the State of Florida.

B. Pursuant to the authority of the Act, the District issued its Capital Improvement Revenue Bonds, Series 1999C (the "1999C Bonds") and its Capital Improvement Revenue Bonds, Series 2005 (the "2005 Bonds" and together with the 1999C Bonds, the "District Bonds") for purposes of financing various infrastructure improvements within the District which provide benefits to the lands within the District.

C. The 1999C Bonds were issued pursuant to the Act and the Master Trust Indenture, dated as of July 1, 1999 (the "Master Indenture"), by and between the District and the Trustee, as supplemented by that certain First Supplemental Trust Indenture, dated as of July 1, 1999.

D. The 2005 Bonds were issued pursuant to the Act and the Master Indenture, as supplemented by that certain Fourth Supplemental Trust Indenture, dated as of February 1, 2005.

E. Pursuant to the Act and Chapter 170, Florida Statutes, as amended, the District levied non-ad valorem special assessments (the "Debt Assessments") securing the District Bonds on those developable portions of the benefitted lands within the District.

F. Pursuant to the Act and Chapter 170, Florida Statutes, as amended, the District also levied non-ad valorem special assessments (the "O&M Assessments") to pay the operating and maintenance expenses of the District.

G. American recently acquired the parcels identified as Parcel ID No. 5228 00 00 0060 ("SW-30") and Parcel ID No. 5229 00 00 0100 ("Parcel 32" together with SW-30, the "Delinquent Parcels") within the District.

H. There exists certain delinquencies in Debt Assessments and O&M Assessments against the Delinquent Parcels.

I. American desires to enter into this Agreement to pay the amounts described herein to cure the delinquencies against the Delinquent Parcels.

J. The District, through the Trustee, has received direction from not-less-than one hundred percent (100%) of the holders of the District Bonds to enter into this Agreement on their behalf.

NOW, THEREFORE, based upon good and valuable consideration and the mutual covenants of the parties, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. INCORPORATION OF RECITALS. The recitals stated above are true and correct and are incorporated by reference herein as a material part of this Agreement.

2. AMERICAN OBLIGATIONS. In order to induce the District and Trustee to execute, deliver and perform under this Agreement, American covenants and agrees to pay the following amounts with respect to the Delinquent Parcels (collectively, the "Settlement Amount") within ten (10) business days of the Effective Date:

- (A) to pay fifty percent (50%) of the delinquent principal amortization installments for the Debt Assessments due with respect to the 1999C Bonds in an amount equal to \$35,848 and its 2005 Bonds in an amount equal to \$73,919.29;
- (B) to pay the O&M Assessments currently outstanding and levied against the Parcel 32 in an amount equal to \$9,500;

In addition, American agrees to (i) pay \$731,647.70 of the balance of the Debt Assessments related to SW-30 (\$817,675.69 less the payment of delinquent principal of \$86,027.99) and \$114,161 (\$137,900 less the payment of delinquent principal of \$23,739) of the balance of the Debt Assessments related to Parcel 32 as such amounts would come due after the Debt Assessments are decelerated for Fiscal Year 2019 and beyond and the original amortization schedule is reinstated in accordance with Exhibit B attached hereto and (ii) enter into a true-up agreement with respect to the Delinquent Parcels providing for a true up payment in the event less than a total of 464 units are platted on the Delinquent Parcels.

Upon payment of the Settlement Amount the District and Trustee warrant and represent American will be current in all amounts owed to the District with respect to the Delinquent Parcels with only regularly scheduled (decelerated) assessments coming due after November 1, 2018.

3. In order to induce American and Trustee to execute, deliver and perform under this Agreement, the District covenants and agrees that upon receipt of the Settlement Amount, as described herein, the District shall:

- (A) waive all past due O&M Assessments on SW-30 and all penalties imposed on the past due O&M Assessments with respect to the Delinquent Parcels;
- (B) waive all penalties imposed on the past due Debt Assessments with respect to the Delinquent Parcels;
- (C) waive all past due accrued and unpaid interest on the past due Debt Assessments with respect to the Delinquent Parcels;
- (D) execute and record a satisfaction of lien for all unpaid assessments, penalties and liens due in connection with the Delinquent Parcels, including those liens listed on Exhibit A; and
- (E) execute and record a satisfaction and release of all liens encumbering the Delinquent Parcels relating to delinquent Special Assessments.

4. **DEEMED AMENDMENT OF INDENTURE; CONSENT.** To the extent that the provisions of this Agreement conflict with any provision of the Master Indenture, the Master Indenture shall be deemed to be amended to conform to the conflicting provision of this Agreement. Consent to such amendment shall be evidenced in the written consent of the Beneficial Owners of one hundred percent (100%) of the outstanding District Bonds to this Agreement, including, but not limited to, the provisions of this Section 8 and direction to the Trustee to execute this Agreement in their stead and on their behalf.

5. **AGREEMENT.** This instrument shall constitute the final and complete expression of this Agreement among the parties relating to the subject matter of this Agreement.

6. **AMENDMENTS.** Amendments to and waivers of the provisions contained in this Agreement may be made only by an instrument in writing which is executed by all of the parties hereto and subject to the written consent of not less than 100% of the outstanding District Bonds.

7. **AUTHORIZATION.** The execution of this Agreement has been duly authorized by the appropriate body or official of all Parties hereto, each Party has complied with all the requirements of law, and each Party has full power and authority to comply with the terms and provisions of this instrument.

8. **THIRD PARTY BENEFICIARY.** The Parties hereto agree and acknowledge that the Trustee is executing this Agreement with the consent of, and at the direction of, the Bondholders of the District Bonds and that the Bondholders of the District Bonds, although not a signatory hereto, are nonetheless third party beneficiaries of this Agreement. The Parties further agree and acknowledge that the covenants, settlements, representations and warranties

made herein by the Parties are also for the benefit of American's successors in title to the Delinquent Parcels.

9. CONTROLLING LAW AND VENUE. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of Florida. Each Party consents that the venue for any litigation arising out of or related to this Agreement shall be in Volusia County, Florida.

10. EFFECTIVE DATE AND TERM. This Agreement shall be effective as of the Effective Date. If American fails to timely pay the Settlement Amount, then this Agreement shall terminate in its entirety. Upon any such termination, any amounts that are due and owing as to the Delinquent Parcels, including, but not limited to Debt Assessments that have accrued, shall immediately become due and payable to the District.

11. AMERICAN'S REPRESENTATIONS, WARRANTIES AND COVENANTS. American hereby represents and warrants to the District and the Trustee that:

(a) American is a limited liability company, duly organized and validly existing in the State of Florida;

(b) American has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations hereunder;

(c) The person executing this Agreement on behalf of American represents that he or she is duly authorized to execute this Agreement and to bind American;

(d) Neither the execution and delivery of this Agreement nor the performance hereunder by American will result in any breach of, or constitute a default under or conflict with, any agreement, covenant or obligation binding upon American; and

(e) This Agreement has been duly authorized and executed by American in accordance with the articles of organization, operating agreement and other applicable organizational documents of American.

12. REPRESENTATIONS AND WARRANTIES OF THE DISTRICT. The District hereby represents and warrants to American and the Trustee that:

(a) The District is a unit of special purpose government duly organized and validly existing in good standing under Chapter 190, Florida Statutes;

(b) The District has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations under this Agreement;

(c) This Agreement has been duly authorized and executed by the District in accordance with all applicable law and authority documents applicable to the District;

(d) The person executing this Agreement on behalf of the District represents that he or she is duly authorized to execute this Agreement and to bind the District; and

(e) Neither the execution and delivery nor the performance of this Agreement by the District conflicts with, is a breach of, or constitutes a default under, any agreement, covenant or obligation binding upon the District.

13. REPRESENTATIONS AND WARRANTIES OF THE TRUSTEE. The Trustee hereby represents and warrants to American and the District that:

(a) The Trustee is executing this Agreement solely at the direction and consent of 100% in principal amount of the Holders of the Outstanding District Bonds.

(b) The Trustee is a national banking association duly organized and validly existing in good standing under the law of the United States;

(c) The Trustee has the requisite right, legal capacity, power and authority to enter into this Agreement and to perform its obligations under this Agreement;

(d) This Agreement has been duly authorized, executed and delivered by the Trustee in accordance with all applicable organizational and authority documents of Trustee and any agreements binding upon Trustee;

(e) The person executing this Agreement on behalf of the Trustee represents that he or she is duly authorized to execute this Agreement and to bind the Trustee; and

(f) Neither the execution and delivery nor the performance of this Agreement by the Trustee conflicts with, is a breach of, or constitutes a default under, any agreement, covenant or obligation binding upon the Trustee.

14. NOTICES. Except as may be expressly stated to the contrary in this Agreement, notices, documents, demands, or certificates given by any Party in connection with this Agreement or the performance by either Party under this Agreement shall be in writing and shall be delivered or sent by one of the following methods: (a) in person (by hand delivery or professional messenger service) to the addressee Party, (b) registered or certified mail, with postage prepaid, return receipt requested, (c) Express Mail of the U.S. Postal Service or Federal Express (a/k/a FedEx) or any other courier service guaranteeing next business day delivery, charges prepaid, or (d) by facsimile transmission (provided a hard copy of such transmission is simultaneously sent or delivered by one of the above prescribed methods). Notices shall be sent or delivered to the following addresses:

For the purposes of this Agreement, the term "Business Day" shall mean and refer to any day that is not a Saturday, Sunday, or national holiday.

16. GOOD FAITH AND FAIR DEALING. The Parties agree to exercise good faith and fair dealing in the performance of their respective contractual obligations hereunder.

17. PUBLIC RECORDS. The Parties understand and agree that all documents of any kind provided to the District or American in connection with this Agreement may be public records and treated as such in accordance with Florida law.

18. SURVIVAL OF CERTAIN PROVISIONS. The provisions of Sections 8, 9, 18 and 21 of this Agreement shall survive the expiration or earlier termination of this Agreement. Section 3 shall survive the expiration of this Agreement.

19. SEVERABILITY. The invalidity or unenforceability of any one or more provisions of this Agreement shall not affect the validity or enforceability of the remaining portions of this Agreement, or any part of this Agreement not held to be invalid or unenforceable.

20. LIMITATIONS ON LIABILITY. Nothing in this Agreement shall be deemed as a waiver of immunity or limits of liability of the District beyond any statutory limited waiver of immunity or limits of liability which may have been adopted by the Florida Legislature in Section 768.28, *Florida Statutes*, or other statute, and nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law.

In addition, any provision of this Agreement to the contrary notwithstanding, the Trustee has executed this Agreement only in its capacity as the trustee under the Master Indenture and only for the purpose of evidencing the consent of the Bondholders of the District Bonds to the transactions contemplated herein, and not individually or for the purpose of being bound in its individual or personal capacity. The Trustee shall not have any individual or personal liability under or related to this Agreement

21. FURTHER ASSURANCES. The Parties agree to execute, acknowledge, deliver and record such certificates, amendments, instruments, and documents, and to take such other action, as may be reasonably necessary to carry out the intent and purposes of this Agreement.

22. COUNTERPARTS. This Agreement may be executed in any number of counterparts, each of which when executed and delivered shall be an original; however, all such counterparts together shall constitute, but one and the same instrument. Signature and acknowledgment pages, if any, may be detached from the counterparts and attached to a single copy of this document to physically form one document.

23. WAIVER OF JURY TRIAL. To the extent permitted by applicable law, each of the Parties, knowingly, voluntarily and intentionally waives any right each may have to a trial by jury in respect of any litigation based on, or arising out of, under or in connection with this Agreement, or any course of conduct, course of dealing, statements (whether verbal or written) or actions of any party with respect hereto.

Our firm represents American SW-30 Investments LLC ("American") the owner of certain lands that were recently acquired and certain lands under contract within the Indigo Community Development District (the "District") American currently owns Parcel ID No. 5228 00 00 0060 ("SW-30"). American has Parcel ID No. 5229 00 00 0100 ("Parcel 4") under contract to purchase from the current owner. Both parcels are undeveloped in the Southern portion of the District.

We are working with the holders of the District's Series 1999C Bonds and the Series 2005A Bonds regarding the delinquencies in the debt service assessments against the parcels. Originally SW-30 assessments were based on 38 single family units. In 2014 this assessment was increased to 681 units. It is our understanding that there has never been any jurisdictional wetland lines approved for either parcel. Without this information there is no way of determining, with any level of certainty, the ultimate number of units that can be developed on this parcel.

In Fiscal Year 2010/2011 SW-30, the O&M assessment against SW-30 was \$5,564.81 or approximately \$146 per unit. In FY 2011/12 through FY 2013/2014 this assessment was increased to approximately \$149,000 or approximately \$3,900 per unit. Please note the reallocation of assessments that increased the unit count from 38 to 681 did not occur until 2014. After the reallocation of the assessments in 2014, O&M assessments equaled an assessment of approximately \$419/acre based on an acreage of 355 acres or \$218 per unit based on a unit count of 681 units. For the current fiscal year 2018 the O&M assessment was \$70,749. This is approximately \$200/acre or \$103/unit.

Compare this information to the O&M assessments levied against Parcel 4 which for 2018 was \$9,497.62. On a per acre basis that equates to approximately \$250/acre or \$100/unit. Parcel 4 is approximately 37 acres and has been assessed for 94.12 units. The jurisdictional wetlands have

also never been determined for Parcel 4. Parcel 4 was also reallocated assessments in 2014 with an increase of 34.12 units without any regard to any wetland delineation.

This information is being provided to evidence that both SW-30 and Parcel 4 have been assessed a substantial portion of the O&M budget and these amounts have consistently been paid since the O&M assessment was placed on the tax rolls.

American has been working with Bio-Tech Consulting and has received a preliminary site plan containing 64 units for Parcel 4 taking into account their preliminary wetlands determination which needs to be confirmed by the Army Corp of Engineers in approximately 5 to 7 weeks. Based on preliminary wetlands delineation information from Bio-Tech Consulting, American believes the unit count for SW-30 is approximately 250 single family units.

Based on an estoppel letter provided to American by the District's manager there remains outstanding approximately \$451,000 of O&M assessments from FY 2010/2011 through 2013/2014 at which time the assessments were placed on the tax rolls. In addition the letter indicates penalty interest in the amount of an additional \$286,699.06 through June 30, 2018. On a per unit basis that adds an additional \$2,950 per lot to the development costs. American estimates transportation mitigation costs of an additional \$3,000 per lot due to the lack of capacity on LPGA Boulevard. Wetlands mitigation costs are approximately \$180,000 per acre. These costs don't even begin to include the cost to develop the lots. The successful sale of tax certificates in the future given the level of liens and development costs that are surfacing may be remote.

In order to put SW-30 and Parcel 4 in the best position to be developed, American is proposing that the unit counts for SW-30 and Parcel 4 be adjusted to 340 and 61, respectively, and O&M assessment be based on \$103 for undeveloped lots until such time as platting occurs. At the time of platting the District will assess O&M against the final number of units platted. The District would also agree to waive the past due O&M assessments and the penalty interest.

We have included a site plan showing the preliminary wetlands delineation that has been prepared based on information provided by Bio-Tech Consulting. In addition we have included a summary of the settlement terms being proffered to the holders of the District's Series 1999C Bonds and Series 2005A Bonds.

We look forward to a response to this proposal which we believe will put these parcels in a great position to be developed pursuant to a comprehensive and cohesive development plan.



Per your request the Indigo Community Development District is providing this estoppel letter, including payoff amounts, in connection with the Property identified above. The Property listed above has been assigned (681) (Single Family Residential) Assessment Units per the District's April 2, 2014 *Supplemental Special Assessment Methodology Reports for the Capital Improvement Revenue Bonds, Series 1999C and Series 2005* ("Methodologies").

This Property is subject to (2) Bond Issues, Series 1999C Bond Debt, maturing May 1, 2030 and Series 2005 Bond Debt maturing May 1, 2036 ("Bonds"). Both Bonds are secured by annual Debt Service Assessments equal to the Bonds' annual principal and interest payment ("Debt Service Assessments"). Pursuant to Florida Statute 170.10, upon default in payment of Debt Service Assessments, the whole Assessment, with interest and penalties thereon, shall immediately become due and payable and subject to foreclosure.

The total amount currently due for the Series 1999C Debt is \$660,077.33. This amount is comprised of the current principal balance of the Series 1999C Bonds related to this Property of \$354,511.99, accrued interest at 7% of \$117,901.29, as well as penalties of 1% per month accrued on the past due balances pursuant to Section 170.09, Florida Statutes of \$187,664.06. Interest is through fiscal year 2018 and penalties are through 6/30/18, please note that there are significant amounts of accrued interest and penalties on Bond balances prior to restructure as well as balances post restructure. Past due Series 1999C principal payments through fiscal year 2018 total \$ 57,990.97. If this Property is made current, the gross Series 1999C Debt Service Assessment will be \$ 39,715.92.

The total amount currently due for the Series 2005 Debt is \$1,894,508.11. This amount is comprised of the current principal balance of the Series 2005 Bonds related to this Property of \$1,031,378.79, accrued interest at 5.75% of \$293,225.92, as well as penalties of 1% per month accrued on the past due balances pursuant to Section 170.09, Florida Statutes of \$569,903.40. Interest is through fiscal year 2018 and penalties are through 6/30/18, please note that there are significant amounts of accrued interest and penalties on Bond balances prior to restructure as well as balances post restructure. Past due Series 2005 principal payments through fiscal year 2018 total \$114,064.99. If this Property is made current, the gross Series 1999C Debt Service Assessment will be \$ 88,441.47.

In addition to the Debt Service Assessments, the Property is subject to annual Operations and Maintenance Assessments ("O&M Assessments"). The O&M Assessments are subject to change from year to year pending the annual adopted budget and will continue for the life of the

District. For Fiscal Year 2011 (10/1/10 – 9/30/11), the O&M Assessment for this Property was \$5,564.81. For Fiscal Year 2012 (10/1/11 – 9/30/12), the O&M Assessment for this Property was \$ 149,257.43. For Fiscal Year 2013 (10/1/12 – 9/30/13), the O&M Assessment for this Property was \$ 149,257.43. For Fiscal Year 2014 (10/1/13 – 9/30/14), the O&M Assessment for this Property was \$ 148,316.71. Fiscal years 2011 through 2014 remain unpaid, and have accrued penalties of 1% per month pursuant to Section 170.09, Florida Statutes totaling \$ 286,699.06. The total amount due to the District through 6/30/18 for O&M plus penalties is **\$ 739,095.44 .**

Note that Fiscal Years 2015, 2016, 2017 and 2018 O&M Assessments were placed on the 2014, 2015, 2016 and 2017 Volusia County Property Tax bills associated with the above referenced Property for collection. **Please contact the Volusia County Property Tax Collector's office for total amounts due for fiscal years 2015-2018 (property tax years 2014-2017).** Fiscal Year 2018 O&M for this Property is \$ 70,749.09 which is collected via the 2017 Volusia County Property Tax bill.

Landowners within each Assessment Area are responsible for completing the Development Program as outlined in the Methodologies. If a landowner does not build the units set forth in the Methodologies, the landowner will be required to make a density reduction payment equal to the remaining par debt per unit multiplied by the difference between the Development Units built and the number of units specified in Methodologies upon platting. Landowner will be responsible for Operations and Maintenance assessments specified in the Development Program and Budget until the following fiscal year.

Please take notice that the District is unable to accept partial late payments without the express consent of the trustee on behalf of bondholders.

There is a \$150 processing fee payable to Governmental Management Services, LLC for this estoppel which has been paid in full.





This Property is subject to (2) Bond Issues, Series 1999C Bond Debt, maturing May 1, 2030 and Series 2005 Bond Debt maturing May 1, 2036 ("Bonds"). Both Bonds are secured by annual Debt Service Assessments equal to the Bonds' annual principal and interest payment ("Debt Service Assessments"). Pursuant to Florida Statute 170.10, upon default in payment of Debt Service Assessments, the whole Assessment, with interest and penalties thereon, shall immediately become due and payable and subject to foreclosure.

The total amount currently due for the Series 1999C Debt is \$100,948.16. Landowner will be responsible for Operations and Maintenance assessments specified in the Development Program and Budget until the following fiscal year.

There is a \$150 processing fee payable to Governmental Management Services, LLC for this estoppel which has been paid in full.




1.0 Introduction

Every individual must have equal access to information whether it is in person service or online. This is a general agreement and understanding of access.

The Internet has dramatically changed the way state and local governments do business. Today, government agencies routinely make much more information about their programs, activities, and services available to the public by posting it on their websites. As a result, many people can easily access this information seven days a week, 24 hours a day.

Many government services and activities are also provided on websites because the public is able to participate in them at any time of day and without the assistance of government personnel. Many government websites offer a low cost, quick, and convenient way of filing tax returns, paying bills, renewing licenses, signing up for programs, applying for permits or funding, submitting job applications, and performing a wide variety of other activities.

The **Americans with Disabilities Act (ADA)** and, if the government entities receive federal funding, the Rehabilitation Act of 1973 generally require that state and local governments provide qualified individuals with disabilities equal access to their programs, services, or activities unless doing so would fundamentally alter the nature of their programs, services, or activities or would impose an undue burden. One way to help meet these requirements is to ensure that government websites have accessible features for people with disabilities, using the simple steps described in this document. An agency with an inaccessible website may also meet its legal obligations by providing an alternative accessible way for citizens to use the programs or services, such as a staffed telephone information line. These alternatives, however, are unlikely to provide an equal degree of access in terms of hours of operation and the range of options and programs available.

1.1 Common Problems and Solutions in Website Accessibility?

1.1.1 Problem: Images Without Text Equivalents

Solution: Add a Text Equivalent to Every Image

Adding a line of simple HTML code to provide text for each image and graphic will enable a user with a vision disability to understand what it is. Add a type of HTML tag, such as an “alt” tag for brief amounts of text or a “longdesc” tag for large amounts, to each image and graphic on your agency’s website.

The words in the tag should be more than a description. They should provide a text equivalent of the image. In other words, the tag should include the same meaningful information that other users obtain by looking at the image. In the example of the mayor’s picture, adding an “alt” tag with the words “Photograph of Mayor Jane Smith” provides a meaningful description.

In some circumstances, longer and more detailed text will be necessary to convey the same meaningful information that other visitors to the website can see. For example, a map showing the locations of neighborhood branches of a city library needs a tag with much more information in text format. In that instance, where the map conveys the locations of several facilities, add a “longdesc” tag that includes a text equivalent description of each location shown on the map – e.g., “City Center Library, 433 N. Main Street, located on North Main Street between 4th Avenue and 5th Avenue.”

1.1.2 Problem: Documents Are Not Posted In an Accessible Format

Solution: Post Documents in a Text-Based Format

Always provide documents in an alternative text-based format, such as HTML or RTF (Rich Text Format), in addition to PDF. Text-based formats are the most compatible with assistive technologies.

1.1.3 Problem: Specifying Colors and Font Sizes

Solution: Avoid Dictating Colors and Font Settings

Websites should be designed so they can be viewed with the color and font sizes set in users’ web browsers and operating systems. Users with low vision must be able to specify the text and background colors as well as the font sizes needed to see webpage content.

1.1.4 Problem: Videos and Other Multimedia Lack Accessible Features

Solution: Include Audio Descriptions and Captions

Videos need to incorporate features that make them accessible to everyone. Provide audio descriptions of images (including changes in setting, gestures, and other details) to make videos accessible to people who are blind or have low vision. Provide text captions synchronized with the video images to make videos and audio tracks accessible to people who are deaf or hard of hearing.

1.1.5 Web Content Accessibility Guidelines (WCAG)

Understanding the Four Principles of Accessibility

The guidelines and Success Criteria are organized around the following four principles, which lay the foundation necessary for anyone to access and use Web content. Anyone who wants to use the Web must have content that is:

1. **Perceivable** - Information and user interface components must be presentable to users in ways they can perceive.
 - This means that users must be able to perceive the information being presented (it can't be invisible to all of their senses)
2. **Operable** - User interface components and navigation must be operable.
 - This means that users must be able to operate the interface (the interface cannot require interaction that a user cannot perform)
3. **Understandable** - Information and the operation of user interface must be understandable.
 - This means that users must be able to understand the information as well as the operation of the user interface (the content or operation cannot be beyond their understanding)
4. **Robust** - Content must be robust enough that it can be interpreted reliably by a wide variety of user agents, including assistive technologies.
 - This means that users must be able to access the content as technologies advance (as technologies and user agents evolve, the content should remain accessible)

If any of these are not true, users with disabilities will not be able to use the Web.

Under each of the principles are guidelines and Success Criteria that help to address these principles for people with disabilities. There are many general usability guidelines that make content more **usable by all people**, including those with disabilities. However, in WCAG 2.1, we only include those guidelines that address problems particular to people with disabilities. This includes issues that block access or interfere with access to the Web more severely for people with disabilities.

See reference section at the end of this document for more information and websites for ADA, Usability and other important compliance issues and solutions.
